Meeting called to order at 7:00 PM with nine members present

Chair Steedman Lyles called the meeting to order and welcomed guests and members of the Livability Board. The December 2018 Livability Board Meeting is a special session designed for the Livability Board and other town residents to participate in the Town of Davidson's Comprehensive Plan, "What's Next Davidson."

Mr. Trey Akers shared a presentation that provided an overview to the Town of Davidson Comprehensive Plan. The Town of Davidson has continued to advance the planning work to develop a new comprehensive plan, which will act as the leading policy document and a planning tool to ensure that the Town of Davidson continues sustain a thriving population of residents. Three members of the Livability Board—Dave Cable, John Cock, Patrick Coleman—serve as liaisons to the planning team responsible for managing the process of drafting and finalizing the comprehensive plan. The RFP process is now completed, and a team of consultants led by Clarion Associates. Additional information will be shared on the What's Next Davidson website.

The comprehensive plan is the blueprint for the future, a compass that guides decision-making, a playbook for where capital investments are made, and a messaging tool for articulating the vision of the community. The Town of Davidson asked residents to complete a survey designed to gather information about how well the Town of Davidson is adhering to the seven planning principles that align to the values of the Town of Davidson.

To date, there are 628 completed surveys, which represents 4.28 percent of the total population of Davidson. The survey mechanism is just one way that the planning team is gathering information; they also have been conducting small focus group conversations with community organizations and stakeholders. In total, more than 1,300 points of contact in addition to the completed surveys and the stakeholder focus groups have been made by the planning team.

A community workshop, "Conversation on What's Next," is planned for January 17, 2019 from 6:30–8:30p.m. at the Lilly Family Gallery at Davidson College. This community workshop is a chance for town residents to come together, learn about critical planning influences, and provide ideas on how to ensure Davidson is a thriving community where all residents feel as though they're involved and feel as though they belong. Registration is free and the planning committee is asking residents to register in advance on the What's Next Davidson website.

The Town of Davidson uses a framework of <u>general planning principles</u>, and the "What's Next Davidson" planning process is designed to check, verify, and update if needed. The Livability Board and guests of the meeting participated in a series of planned activities to discuss the planning principles and factors for the planning team to consider in continuing their work on the comprehensive plan. Director Kathryn Spatz encouraged those present to complete the What's Next Davidson survey. No further updates from staff or Subcommittees occurred.

The meeting adjourned at 8:15 PM with a unanimous vote, 9–0.
