Budget Amendment 2018-01 - The purchase of the 228 Sloan Street property (originally approved in FY 2017) was moved to FY2018.

Budget Amendment 2018-02 - Allows for the approved budget ordinance allocation to the Arts Project Fund to be recognized in the project fund.

Budget Amendment 2018-03 - The Town has been awarded and additional \$65,000 in HOMES down payment assistance by Mecklenburg County.

Budget Amendment 2018-04 - Provides down payment assistance for one home from Affordable Housing payments in lieu.

Commissioner Cashion made the motion to approve the consent agenda. The motion passed unanimously.

- **New Business**

Chairman of the Livability Board Marty Metzger provided the livability board's recommendation for the allocation of \$50,000 appropriated for contributions to non-profits. Board

Commissioner Anderson motioned to fund the Davidson Housing Coalition from Affordable Housing funds next fiscal year and moved to approve the allocation of non-profit funding. Both motions passed unanimously.

- **Old Business**

Consider Approval of Ordinance 2017-10: Miscellaneous Text Amendments to the Davidson Planning Ordinance.

Commissioner Anderson motioned to approve Ordinance 2017-10. The motion passed unanimously.

Consider Approval of the Consistency Statement for the proposed Miscellaneous Text Amendments.

Commissioner Fuller motioned to approve the consistency statement. The motion passed unanimously.

Consider Approval of three resolutions:

Resolution 2017-16 - Use of payments that are made in lieu of providing open space in the Rural Area Plan study area

Resolution 2017-17 - Use of payments that are made as contributions toward the implementation of the connectivity and Traffic Calming Plan

Resolution 2017-18 - Use of payments in lieu of providing required parking spaces in the village parking overlay district

Commissioner Anderson made the motion to approve resolutions 2017-16, 2017-17 and 2017-18 as amended. The motion passed unanimously.

Consider Introduction of Bond Order Authorizing the Issuance of \$6,000,000 General Obligation Mobility Bonds

Commissioner Cashion made the motion to approve the Introduction of Bond Order Authorizing the Issuance of \$6,000,000 General Obligation Mobility Bonds. The motion passed unanimously.

Consider Introduction of Bond Order Authorizing the Issuance of \$5,000,000 General Obligation Greenway Bonds

Commissioner Fuller made the motion to approve the Introduction of Bond Order Authorizing the Issuance of \$5,000,000 General Obligation Greenway Bonds. The motion passed unanimously.

Consider Introduction of Bond Order Authorizing the Issuance of \$4,000,000 General Obligation Parks and Recreation Bonds

Commissioner Anderson made the motion to approve the Introduction of Bond Order Authorizing the Issuance of \$4,000,000 General Obligation Parks and Recreation Bonds. The motion passed unanimously.

Consideration of Resolution 2017-15 - Approval of Bond Order Set Public Hearing Date regarding three (3) bond orders.

Commissioner Graham made the motion to approve resolution 2017-15. The motion passed unanimously.

Consideration of approval of Beaty Street Developer. Assistant Town Manager Dawn Blobaum provided an updated presentation of a new Luminous/Davidson Development Partners proposal for consideration by the board.

Commissioner Fuller motions to table the Beaty Street vote indefinitely. The motion did not pass (1-4) Commissioner Fuller in favor and Commissioners Anderson, Cashion, Graham, and Jenest against.

Commissioner Anderson motions to direct the staff to negotiate and discuss a contract with the developer and add a combination of town staff, town board members and town citizens. The motion passed (3-2) Commissioners Anderson, Graham, and Jenest in favor and Commissioners Cashion and Fuller against.
