Meeting was called to order at 7:03 p.m.

1. Minutes were adopted

- 2. Shannon Keohane (recent graduate from NW School of the Arts) presented a project that was completed in Matthews, NC as a part of her senior capstone. The project includes painting manhole covers along greenway sewer pipeline systems. Each manhole is painted by a different artist who is chosen through an application process. Shannon would like to do this along the Davidson greenway which includes 28 manhole covers. For the next step, Kathryn and Shannon will to go door-to-door to homeowners along Hudson Place and other streets that include homes who back up to the greenway to seek input.
- 3. Marty Metzker presented the strawman for the non-profit grant funding. There was discussion that the Livability Board should take into account non-profits who have other funding sources, as well as, looking at each non-profit and how their organization benefits the Davidson community. After a brief discussion, the Livability Board reached a consensus on the funding breakdown to be awarded. A motion was made and seconded to take our recommendation to the Board of Commissioners.
- 4. Sub-committee reports
 - a. Walks and Rolls Kathryn Spatz gave an update on the Greenway Summit that was led by the Davidson Lands Conservancy.
 - b. Parks and Recreation Kathryn Spatz gave an update on the Bailey Springs Park. Kathryn also mentioned that Mecklenburg County would be having the kick-off for the North Mecklenburg Recreation Center sometime in August.
 - c. Trees and Natural Assets The committee is exploring planting sites for the fall. The planning department is reviewing Section 9 of the planning ordinance pertaining to trees and landscaping.

The meeting adjourned to sub-committees at 8:05 pm. The next meeting is scheduled for July 18, 2017.
